CONTENTS

Content and Scope of Collection

The Herman Dean papers consist of printed material, correspondence, clippings from magazines and newspapers, and photographs. Personal papers include correspondence, deeds, financial papers, printed material and photographs, related to Byron Dean, Laura Dean, Mary Spragg McCallister Dean, and other family members. These papers date from 1900 to circa 1964.

Business papers date from 1919 to 1949 and include legal documents pertaining to the purchase of the Wayne News in 1919 (later became the *Wayne County News*). The Huntington Standard Printing and Publishing Company materials include paste ups, galley proofs, and correspondence from authors and organizations as well as book reviews, illustrations and photographs related to the company's publications. Also included are items related to the development of Meadow Haven, a subdivision located in the Spring Valley area of Huntington, West Virginia, in Wayne County.

Part of the collection relates to Mr. Dean's many travels to Canada, especially to the area of the Hudson Bay Company in the 1950s. Included are photographs and snapshots, mainly unidentified, of persons and boats, as well as correspondence, circular letters, itineraries, mimeographed material, and newspaper clippings.

Firearms papers include correspondence related to Mr. Dean's avid collecting of firearms and other items. Here are located the publications collected by Mr. Dean, either by subscription or by purchase through auction houses, as well as several scrapbooks containing information about various firearms.

Printed material not described previously comprise the remaining papers. There are also many unidentified snapshots and negatives, primarily from Mr. Dean's travels in Canada and the Hudson's Bay area.

Biography

Born in Wayne, West Virginia, on May 6, 1897, to Byron and Laura Osborn Dean, Herman Palmer Dean was known as a journalist, publisher, businessman, traveler and firearms expert and collector.

His interest in journalism developed at a young age. When he was just nine years old, Dean wrote a weekly column for *The Herald-Advertiser*, which was the combined Sunday edition of *The Herald-Dispatch* and *The Huntington-Advertiser*, now defunct. Dean attended Bethany College and Ohio State University majoring in journalism. After serving in the Navy during World War I, he returned to Wayne and bought *The Wayne News*, changing its name to *The Wayne County News* to signify its reach across the county. In 1932, Dean bought Standard Printing and Publishing Company, which was located in Huntington.

On May 13, 1935, Dean married Mary Spragg McCallister, mother of William Carroll McCallister from a previous marriage.

Not long after he purchased the *Wayne News*, Dean began the first of his many travel explorations. His journeys took him through Europe, Russia, and South America, and the Arctic regions, such as Hudson Bay. Dean traveled with Hudson's Bay Company to different regions and provinces in Canada. As an avid hunter, Dean was knowledgeable about firearms, and began collecting them as a hobby.

Overall, the Herman P. Dean Firearms Collection holds nearly 400 items, and is widely considered to be one of the finest firearms collections in the country. In 1952, Dean loaned his firearms collection to Huntington Museum of Art (then, Huntington Galleries) and later donated it to the museum.

After retiring in 1961, Dean set up an office in Huntington. He died on January 31, 1978, at the age of 80. Mary McCallister Dean died on May 8, 1970; William died on March 27, 1976. All are buried in Spring Hill Cemetery in Huntington, West Virginia.
